I HAVE BEEN MADE AWARE THAT:

The activities undertaken at the Splash Out Event can be physically challenging and dangerous, and include but are not limited to water and other obstacles, climbing structures and adverse weather.

(c) any other matter for which it would be illegal or unlawful for the Organiser to exclude or attempt to exclude its liability.
